General Terms & Conditions and Commercial Terms attached to the Order Form

General provisions

The Customer accepts that this order is valid only if all of its pages are signed by the Customer and returned by fax or by post within thirty (30) days after the indicated date to ARH. ARH warrants the delivery time if the Order Form is confirmed by the Customer within 2 weeks from issuing.

Unless otherwise agreed and indicated on the Order Form, ARH shall deliver the ordered products only after the prescribed sum (indicated on the Order Form) is credited on ARH's bank account.

Product prices indicated on the Order Form do not include the shipping/delivery costs and not contains the Customer's banking cost, which shall be covered by the Customer. The prices are calculated on EXW HU-2071 Pébál, Hungary parity according to INCOTERMS 2010, unless otherwise agreed and indicated on the Order Form.

ARH retains the ownership and every other title related to the delivered goods until ARH has received all amount indicated on this Order from the Customer.

Technical Support

ARH provides free technical support via Internet, by Phone or by Fax. Support hours: on working days of Hungary, from 9.00 am to 17.30 pm CET. On-site support is subject to further negotiations and available at extra charge.

ARH attempts to provide its best support, provided, that:

- ARH reserves the right to decide the level of required support, and
- ARH explicitly disclaims any direct or indirect claims against this support.

Warranty conditions

For all hardware components a one (1) year repair/replacement warranty applies, unless other conditions are agreed and indicated on the Order Form. Warranty repair and/or replacement can be asserted only at ARH's registered premises; therefore all hardware products subject to warranty claims should be returned to ARH. Repair and/or replacement during warranty period shall be carried on "Carry in" basis; the warranty does not cover costs of transportation from Customer to ARH premises. Warranty is void if the failure is originated by accident, abuse or misuse.

Prior sending the disabled product to ARH's registered premises for warranty repair/replacement, the Customer shall provide ARH with the following details:

- product name
- number of the faulty products
- date of purchasing
- serial number(s) of the faulty product(s)

Based on the above information, ARH will provide the Customer with an RMA form and in case of non-EU Customers a pro-forma invoice as well. These documents shall accompany the returned products.

To simplify the customs process, Customer should return the product(s) to ARH's registered premises using the same courier company as ARH did upon delivery.

ARH is not liable for any delay and extra cost emerged because of the Customer negligence to fulfil the above mentioned obligations, all incidental expenses arising from this are due by Customer. These expenses should be paid prior to receiving the repaired/replaced product.

Provisions related to VAT

 - ii) Target of delivery is outside of EU
 - iii) Product(s) leave EU and it has been proofed by bill of delivery (Customs Document)
- 3) Customer is outside of EU
 - i) Target of delivery is outside of EU
 - iii) Product(s) leave EU and it has been proofed by bill of delivery (Customs Document)

Every other case (even if the delivery address is within the European Union), the VAT will be invoiced and will be calculated separately in the appropriate amount in accordance with the obtaining statutory provisions.

Liabilities

The customer states that he has analysed the risks and rewards by right of this order, as well as the prices and accepts that the liability of ARH and/or its contractor and/or its subcontractor and/or its representatives is limited to the fullest extent permitted by law for any and all injuries, damages, claims, losses, expenses or claim expenses (including attorneys' fees) arising out of this order from any cause or causes. Such causes include, but are not limited to, negligence, errors, omissions, strict liability, breach of contract, or breach of warranty. The Customer accepts that the above mentioned limit is the total net value, which ARH has received from the Customer by right of this order. Under no circumstances will ARH and/or its contractor and/or its subcontractor and/or its representatives be liable for any consequential, indirect, special, punitive, or incidental damages, whether foreseeable or unforeseeable, based on customer claims or those of customers (including but not limited to, claims for loss of data, goodwill, profits, use of money or use of the products/services/software indicated on the order form, interruption in use or availability of data, stoppage of other work or impairment of other assets), arising out of breach or failure of express or implied warranty, breach of contract, misrepresentation, negligence, strict liability in tort or otherwise, except only in the case of personal injury where and to the extent that applicable law requires such liability. In no event will the aggregate liability which ARH and/or its contractor and/or its subcontractor and/or its representatives may incur in any action or proceeding exceed the total amount actually paid by customer for the specific product, service or software that directly caused the damage.

Disputes

All disputes arising out of or in connection with the present order, its breach, termination, validity or interpretation shall be finally settled under the Rules of Proceeding of the Arbitration Court attached to the Hungarian Chamber of Commerce and Industry, Budapest, Hungary by one arbitrator appointed in accordance with the said Rules. The governing law shall be the Hungarian civil law, without regard to any conflict laws provisions. The Parties hereby exclude application of the United Nations Convention on Contracts for the International Sales of Goods from this agreement.
